## **WEPOS Cement Residue Remover**

## **Description:**

Highly effective concentrate. Quickly and easily removes cement residue, mortar residue, lime de-posits, efflorescence and inorganic contamination. For all acid-resistant surfaces.

## Effect:

Fast and smoothly removal of cement films, mortar residues, lime deposits, efflorescence an inorganic contamination.

## **Application:**

For all acid-sensitive surfaces such as ceramic wall and floor tiles, clinker slabs, coarse ceramics, fine stoneware, brick, clay and cotto coverings, slate, quartzite, exposed aggregate concrete and lime-free natural stone such as granite.

#### Direction of use:

Apply according to the amount of cement film straight from the container or up to 1:10 diluted to the pre-wetted surface and distribute with a scrub-bing brush or sponge. Allow to work in for a short period, but avoid drying on. Scrub off the loosened residues with a scrubbing brush and take up with a sponge, suction device or wiping cloth. Rinse off with lots of water.

#### Important:

Always test the surface before use for tolerability. Pre-wet the surface before treatment, especially the grouting. Adjacent surfaces should be protected and wash off any splashes immediately. Avoid touching with metals, enamels or chrome-plated objects.

Limestone-containing natural stones such as mar-ble, shell limestone, Jura, Solnhofener, travertine are sensitive to acids. Use can cause irreversible damage.

Caution in the case of diverse types of granite (e.g. Kashmir White, various Padang types or crystal black). Necessary to test prior to use!


